

## Guidance about sales management

1. **Limitation of attendance**

Registered buyers and their attendances are allowed to enter in the sales ground.  
One registered buyer is able to come with only one attendant. (Kids of three-year-old and older are counted as attendants.)

There is no restriction about the number of attendants for buyers who made a purchase at JRHA Select Sale in 2025, while buyers who made a purchase at JRHA Select Sale in 2023 and 2024 are able to come with three attendants.

Buyers and attendants are required to show their entrance permissions which is sent from JRHA in advance.

Only authorized personnel are able to attend at sale.

2. **Reconfirmation of procedure as auctioneers decide the buyer**

In order to make sure of clarification and speedup, auction concludes as auctioneers knock their hammer and a person who has sent final bid is recognized as the buyer. Bidders are requested to send their bids quickly.

In case a dispute is caused over deciding the buyer, parties concerned must obey the judgement by auctioneers. (Horse Market Operating Regulations, Article 19)

3. **Early Registration and Hand-over of Buyer's Registration Number Tag**

If you applied for buyer's registration by July 3<sup>rd</sup> (Fri), you may, if you so prefer, complete the buyer's registration and receive your buyer's registration number tag at the Sales Office between 2:00pm and 5:00pm on July 12<sup>th</sup> (Sun).

## 5. **Photography Service (Free of Charge)**

The service includes three kinds of photos: photo at sales ring when hammer falls, conformation photo just outside the sales pavilion, and a photo taken with the buyer.

If the buyers would like the photo taken with their purchase, please proceed to the photography corner, located in front of the Repository, immediately after the hammer falls.

All photos will be delivered to the address that is submitted with the buyer registration forms.

If no photo with the buyer is requested, then the package will only include two photos: a photo at sales ring and a conformation photo.

## 8. **Handling of Qualified Tax Invoice under New Tax Invoice System**

Where Seller is registered as a qualified tax invoice issuer under the new system, such invoice will be issued to Buyer in the name of JRHA as authorised mediator using its own qualified tax invoice issuer registration number.

In case Seller, or a part of communal sellers, is non-qualified invoice issuer, it is noted on sales catalogue. Buyers are required to pay tax, regardless seller is qualified tax invoice issuer or non-qualified tax invoice issuer.
