

Standard Chartered Anniversary Cashback with SingSaver Promotion Terms and Conditions

1. The Standard Chartered Anniversary Cashback with SingSaver Promotion (the "**Promotion**") is available from 26 July 2019 to 30 September 2019 (both dates inclusive) (the "**Promotion Period**"). By participating in the Promotion, you agree to be bound by these terms and conditions.

Eligibility

2. To qualify for the Promotion and receive the S\$160 Anniversary Cashback (as defined in Clause 6):
 - b. you must apply for a CashOne Personal Loan ("CashOne") or a Credit Card Instalment Loan with Standard Chartered Bank (Singapore) Limited (the "Bank") via any one of the following websites during the Promotion Period (subject to the caveat in Clause 11 below):
 - (i) www.SingSaver.com.sg ("Channel");
 - c. the new CashOne / Credit Card Instalment Loan with the Bank must be:
 - (i) for a minimum approved loan amount of S\$20,000; and
 - (ii) repayable over a tenure of 12, 24, 36, 48 or 60 months;
 - d. the Bank must have received your Application (as defined at Clause 3 below) during the Promotion Period via the Channel, which must be approved; and
 - e. your CashOne or Credit Card Instalment Loan account (each an "**Account**"), as the case may be, must be validly existing (i.e. must not be suspended, cancelled or terminated), in good standing, and conducted in a proper and satisfactory manner at all times, including at the time of crediting (in the manner set out in Clause 7 below) of the S\$160 Anniversary Cashback (as defined in Clause 6 below) as determined by the Bank in its sole and absolute discretion.
3. For the purposes of this Promotion, each application fulfilling clause 2(a) and 2(b) above is an "**Application**".
4. Notwithstanding the foregoing, the Bank may continue to process any Application received by the Bank for up to seven (7) calendar days after the end of the Promotion Period, and the Bank shall retain the sole and absolute discretion to determine the eligibility of these applications and/or allow the said applications for the purposes of this Promotion on a case-to-case basis, subject to these terms.
5. By participating in the Promotion, you consent to:
 - a. the use of your personal data for marketing purposes, including but not limited to the use of your telephone number to contact you about products and promotions offered by the Bank from time to time via telephone, SMS or multimedia messaging. Such consent will also prevail even if you are registered or subsequently register your contact information with the national Do Not Call Registry; and
 - b. us disclosing your information to each Channel (including their staff) and other persons who are involved in operating or promoting the Promotion and further consent to such persons contacting you for the purposes of marketing the Promotion.

Promotion Mechanics

6. If you satisfy the eligibility criteria set out in Clause 2, you will be eligible to receive a S\$160 cashback ("**Anniversary Cashback**"). For the avoidance of doubt, you are entitled to a maximum of one (1) Anniversary Cashback for this Promotion.
7. The Anniversary Cashback will be credited within 50 working days from the date of approval of your Application, as determined in the Bank's sole and absolute discretion, into:

- a. your credit card account which must be validly existing (i.e. must not be suspended, cancelled or terminated), in good standing, and conducted in a proper and satisfactory manner at all times, as determined by the Bank in its sole and absolute discretion, if you have only one credit card account;
 - b. any one of your credit card accounts, which must be validly existing (i.e. must not be suspended, cancelled or terminated), in good standing, and conducted in a proper and satisfactory manner at all times, as determined by the Bank in its sole and absolute discretion, in the event you have more than one credit card account; or
 - c. your Account, in the event you have no credit card account.
8. The Anniversary Cashback is non-redeemable for cash, non-transferable, non-assignable and non-exchangeable for any other item.
9. The Bank reserves the right to, without compensation, debit the Anniversary Cashback from the credit card account or Account which the Anniversary Cashback is credited into and/or forfeit the Anniversary Cashback, if:
- a. you terminate the Account or credit card account, which the Anniversary Cashback is credited into, for any reason following the crediting of the Cashback to your Account or credit card account; and/or
 - b. the Account or credit card account, which the Anniversary Cashback is credited into, is not valid, subsisting and/or in good standing at any time after the crediting of the Anniversary Cashback under this Promotion, as determined at the Bank's sole and absolute discretion.

General

10. By applying for an Application pursuant to this Promotion, you consent to the use of your personal data for marketing purposes, including but not limited to the use of your telephone number to contact you about products and promotions offered by the Bank from time to time via telephone, SMS or multimedia messaging. Such consent will also prevail even if you are registered or subsequently register your contact information with the national Do Not Call Registry.
11. Unless otherwise stated, this Promotion is not valid with other offers, discounts, rebates, vouchers, privileges or promotions. For the avoidance of doubt, this Promotion is not valid with the CashOne Credit Card Instalment Loan Cheque Campaign, the Anniversary Cashback Promotion, the Anniversary Cashback Telesales Promotion, the Standard Chartered Anniversary Cashback with MoneySmart Promotion, the Exclusive Interest Rate Promotion and the CashOne Comparison Sites Campaign.
12. No payment or compensation whether in cash, credit or kind shall be made for any uncollected, lost, misplaced, or stolen Anniversary Cashback.
13. The Bank reserves the right to replace or substitute the Anniversary Cashback with any item which may or may not be of equivalent or similar value, without prior notice or reason (and the Bank shall not be obliged to disclose its reason).
14. Except for death or personal injury caused by the negligence of the Bank, to the fullest extent permitted by law, the Bank and members of the Bank's group shall have no liability in respect of, and will be indemnified from and against, any liability, loss, claim, damage or costs of any kind (including legal costs) to any person or entity, in whole or in part, directly or indirectly, whether by reason of the acceptance, possession, use or misuse of the Anniversary Cashback.
15. The Bank may vary, modify, add, delete or otherwise revise any of the terms and conditions governing the Promotion or to terminate, withdraw, extend or shorten the Promotion at any time in the Bank's sole discretion, with or without prior notice or reason.
16. The Bank reserves the right to determine in its sole and absolute discretion all matters arising out of or in connection with the Promotion, including your eligibility for the Promotion. The Bank's determination of all matters relating to this Promotion shall be final and binding and no correspondence will be entertained.

17. In the event of any inconsistency between the Promotion Terms and Conditions and any brochures, marketing or promotional materials relating to the Promotion, these Anniversary Cashback SingSaver Promotion Terms and Conditions shall prevail to the extent of such inconsistency.
18. These Promotion Terms and Conditions are to be read in conjunction with the Bank's Customer Terms, the Current / Cheque / Savings Account and Time Deposit Terms, the Personal Loan / Personal Line of Credit / Overdraft Terms, the Credit Card Terms, the CashOne Product Terms and/or the Credit Card Credit Card Instalment Loan Product Terms (as the case may be) as well as any other product terms that may be applicable in conjunction with the Promotion (collectively, the "**Other Terms**").
