Notice Concerning Change to Scope of Consolidated Accounting

en-japan inc. hereby announces that it has decided to change the scope of its consolidated accounting, as shown below, effective the fiscal year ending March 31, 2014.

1. Reason for changing scope of consolidated accounting

As of March 31, 2013, en-japan inc. had 11 subsidiaries, of which nine subsidiaries had continued to be treated as non-consolidated ones given the limited effect they had on the Company's financial statements.

However, en-japan inc. decided to include six of the above-mentioned subsidiaries in the scope of its consolidated accounting in consideration of the possibility that these subsidiaries could have a greater effect on the Company's consolidated financial statements in future.

en-japan inc. also decided to include in its consolidated accounting the two companies that had become its subsidiaries in April 2013, making for a total of eight companies that the Company was to include in the scope of its consolidated accounting.
