## 2. Reasons for the Revision of Operating Results Projections

Our Sales for the first quarter of FY2016 has been performing well due to continuously strong results in application number achieved by our main site, "[en] Career Change Info", and raised awareness of our services among our users and client companies as a result of aggressive promotion activities such as TV commercial ran from June.

For the profit side, operating income, ordinary income, and net income are expected to exceed the previously announced projected figures, supported by the favorable sales performance mentioned above and efficient cost management.

With regard to the full year projection, we do not change the previous projection because we have aggressive earnings plan in the second half and there are uncertainties at the current moment.
