#### SGA relative to sales . Labor costs relative to sales. Advertising, sales promotion costs relative to sales

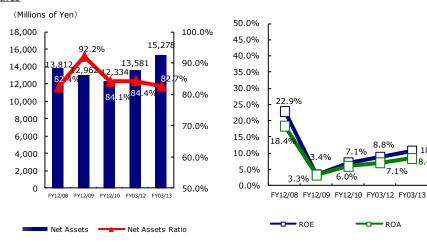
