Requirement:

- 1. If One Or More Of The Samples Fail The Average Char Length Criterion (7.0" Max.), Reject The Design.
- 2. If Three (3) Or More Of The Individual Specimen, From The 15 Selected Specimens, Fail The Individual Char Length Criterion (10.0" Max.), Reject The Design.
- 3. If Only Two (2) Individual Specimen From The 15 Selected Specimens, Fail The Individual Char Length (10.0" Max.), Select Fifteen (15) Additional Specimens For Retest. If One Or More Of The Additional Samples Fail The Average Char Length Criterion (7.0" Max.) Reject The Unit. If Two Or More Of The Additional Individual Specimens Fail The 10.0" Char Length, Reject The Design.
- 4. If All Samples Meet The Average Char Length Criterion And Individual Char Length Criterion, Accept The Design.
